



Human Swine Influenza Situation in Hong Kong

Messages for Visitors and the Travel Trade

Key Messages

- **Travel and business activities as usual:** Travel and business activities are as usual in Hong Kong, a cosmopolitan city of great vitality. There is no restriction on travel.
- **Hong Kong is vigilant and prepared:** The Hong Kong Government remains on high alert against the spread of H1N1. Our world-class medical services, together with **the** mitigation measures in place, has helped ensure that the infected will get timely treatment and prevent the spread of H1N1 within our city.
- **No quarantine of visitors:** While **confirmed** H1N1 patients will be hospitalised for timely treatment, close contacts of confirmed patients will not be put under quarantine.
- **Keep clean, be healthy:** All sectors of the travel industry, including tourist attractions, public transport, restaurants and hotels, and other tourist facilities have been adopting the highest hygiene standards and the necessary preventive measures such as enhanced disinfection of facilities. We also encourage inbound visitors to **observe** good personal hygiene. With all of the above, Hong Kong remains a safe and hygienic city.

Frequently Asked Questions

1. Is it safe to travel or stay in Hong Kong or should I cancel my trip?

It is safe to visit Hong Kong, and there is no need to cancel any trip. WHO is not recommending travel restrictions related to the global outbreak of H1N1. While like the rest of the world Hong Kong is not immune from H1N1, travel and business activities are as usual in Hong Kong.

2. Will I be put under quarantine in a hotel if I had close contact with those who were found infected in Hong Kong?

No. The administration of observed medication to or quarantine of close contacts of H1N1 patients has stopped. Only household contacts of confirmed patients will be put under medical surveillance and health advice will be provided.

3. Will I be denied entry to Hong Kong if I had close contact with an infected person on a flight?

No. Flight passengers in close contact with H1N1 patients will not be traced.

4. Has Hong Kong set up any port health measures?

Yes. Current port health measures at boundary control points for inbound travellers will continue. These include health declaration, temperature screening, and boarding of flights by port health officers when alerted by the crew of sick passengers. Port Health has posted notices at all exit points and will advise all departure and transfer travellers not to travel if they are having fever or flu symptoms.

5. Will I be quarantined if I had a fever or simply flu like symptoms upon my arrival at Hong Kong?

No. You will not be quarantined if you had a fever or other flu like symptoms upon your arrival at Hong Kong. However, you should report this to Port Health officers using the health declaration form. Port Health will conduct an assessment for the need of referral to a hospital/clinic.

6. *Will the whole tour group's itinerary be affected if one of the group members is infected?*

The administration of observed medication to or quarantine of close contacts of H1N1 patients has stopped. Only household contacts of the infected person will be put under medical surveillance and health advice will be provided.

7. *What should I do if I had a fever or simply flu like symptoms during my stay in Hong Kong?*

Local tour guides and travel agents are equipped with the necessary precaution measures. They will help tourists in need to seek medical help. The Hospital Authority has opened eight designated flu clinics for managing patients with influenza-like-illnesses. They shall cater for all patients with influenza-like symptoms (self-referred or referred by other medical practitioners), without the need for prior booking. We will ensure that all patients, whether they are locals or visitors, receive timely and the appropriate treatment. Medical charges at public clinics will be waived if a traveller is referred by the Hong Kong Department of Health on public health reasons.

8. *Do I, as a traveller, have to pay for the relevant medical charges if admitted to a public hospital or clinic for medical check or treatment in relation to H1N1?*

Medical charges at public hospitals/clinics will be waived if a traveller is referred by the Hong Kong Department of Health on public health reasons.

9. *What is the latest situation about the infections in Hong Kong?*

The flu appears to be relatively mild so far, and the current medical treatment is effective. As on 22 June 2009, the total number of H1N1 cases in Hong Kong was 348. Of these infected patients, 195 have been discharged from hospitals. The rest of the confirmed patients were mostly diagnosed last week. They are under treatment in hospitals and their conditions are stable.
